G. COMMISSION COMMENTS

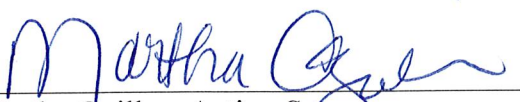

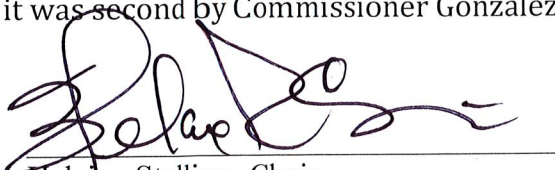
H. ITEMS FOR FUTURE CONSIDERATION
