No public comments were received. At 12:06 p.m., the City Council recessed into a closed session.

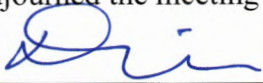

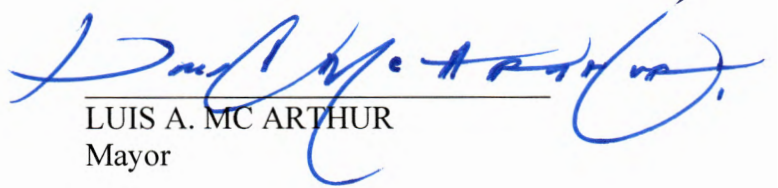
At 1:11 p.m., the City Council reconvened in an open session in the Council Chambers. The City Attorney announced that there are no reportable actions out of closed session.
