G. COMMISSIONER COMMENTS

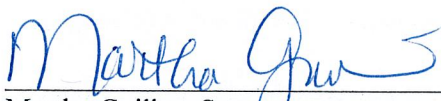
1. Commissioner Tiffany Lopez invited everyone to attend the upcoming Rebozo Festival and Mariachi event.

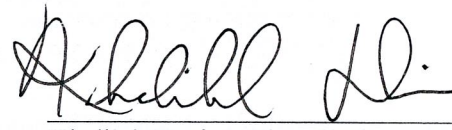
H. ITEMS FOR FUTURE CONSIDERATION
