1. SUBJECT: Presentation by Kelcey Newman, Creative Director ATTAIN design and Marketing Communications regarding the legacy of his mother Ms. Odessa Newman – first African American to serve on the Oxnard School District Board of Trustees and the work he does in the community.

DISCUSSION: The CRC Commissioners received and filed a presentation by Kelcey Newman.

Commissioners expressed their appreciation to Kelcey Newman for his work as an artist and for sharing a Beautiful presentation regarding the legacy of his beloved mother Ms. Odessa Newman-Staples whose spirit of advocacy emerged at the age of 16, when she addressed the Philadelphia neighborhood City Council to promote unity between Black and Puerto Rican families for fair housing rights. She devoted her life to caring for individuals with special needs and fostered dozens of children across Ventura County. She was the first African American to serve on the Oxnard School District Board of Trustees and was named Oxnard Woman of the Year. She then made history again for being the first African American to run for Mayor of Oxnard.
