D. BUSINESS

1. SUBJECT: General Code Compliance Updates
RECOMMENDATION: That the INCO General Membership receive a verbal presentation on general Code Compliance updates from Andrew Dickson, Code Compliance Manager, followed by Q&A.

Code Compliance Manager Andrew Dickson provided an overview of the Code Compliance division's role, including the full staffing of their division, recommendation to utilize the 311 app for any code compliance concerns, and items their division is not responsible for.

Questions included: enforcement of violations on city-owned property, concerns with holiday lights, food cart regulations, short term rental violations, noise complaints, fireworks fines, and the average timeframe for complaints to be addressed.

2. SUBJECT: INCO Goals & Action Items
RECOMMENDATION: That the INCO General Membership receive an update on the 2026 INCO Goals & Action Items from the INCO Executive Board.

Executive Secretary Shapiro shared the 2026 goals adopted by the INCO Executive Board:

- a. Increase membership at INCO general membership meetings to 25 participants
- b. Increase involvement in INCO and the Neighborhood Council program through City events and Neighborhood Council reactivations
- c. Create a living document with the status of all Neighborhood Councils and identify the top three (3) issues facing all Neighborhood Councils
- d. Update a best practices document to support Neighborhood Council chairs

Related to goal “c”, Vice Chair Khalaf shared that a survey asking for the top three issues of each neighborhood will be sent out shortly to chairs, and the intention of this goal is to track the health and activity of the neighborhood councils. Chair Velzy shared additional information related to goal “d”.

Tom McNally, Channel Islands: On 4/14, Public Works & Transportation Committee workshop focused on Water Quality Implementation Plan.

Sandy Diaz, Rio Lindo: Election meeting held on 3/19 and elected vice chair, treasurer, and three members at large. There was no volunteer for Chair and Sandy will be acting chair until there is a volunteer. Bulky item pickup scheduled for 6/6.

Doug Tauber, Via Marina: Neighborhood received two concepts for park improvements at their last neighborhood council meeting.

Daniel Alvarez, La Colonia: Meeting scheduled for 4/22 with traffic engineer update. Shared concern from business owner with activity in the alley.
