2. **Planning and Zoning No. 16-640-01 (Specific Plan Review). Receive and File and Accept the Final Draft Oxnard Corridor Community Transportation Improvement Plan (OCCTIP) Study and Recommend staff proceed to environmental review for possible subsequent adoption. OCCTIP is a comprehensive transportation corridor planning study of 6.0 miles of Oxnard Boulevard, a 2.0 mile segment of Fifth Street, and a 0.4 mile segment of Vineyard Avenue (formerly designated as State Routes 1, 34, and 232, respectively) relinquished in 2013 by the State to the City of Oxnard (City). The study recommends a complete streets program of bicycle lanes and/or paths, ADA-accessible sidewalks and crossings, median and parkway landscaping, comprehensive signage and public art, best management practices, drainage, irrigation, and Gold Coast Transit-designated bus stops. All recommended improvements would be within existing City rights-of-way. OCCTIP also includes three options to: 1) substitute four proposed roundabouts with signalized intersections, 2) reduce Oxnard Blvd. from four to two lanes between Five Points and Third Street, and/or 3) widen Fifth Street from two to four lanes between Rose and Rice Avenues.
