add definitions and zoning related to homeless shelters, transitional housing and supportive housing for low-income and disabled persons, as required by State law (Senate Bill 2). The California Environmental Quality Act (CEQA) does not apply to the proposed zone code text amendment pursuant to the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment, under Section 15061 of the State CEQA Guidelines. - 3. PLANNING AND ZONING PERMIT NO. 11-510-4 (Major Modification to Special Use Permit - Alcohol), a request to allow an existing restaurant (Sol del Pacifico) to serve beer, wine, and distilled spirits for on-site consumption (ABC License Type 47). This approval would be a change from the restaurant's existing special use permit that allows service of beer and wine for on-site consumption (ABC License Type 41). The proposal also includes a request for a nightclub with dancing and live entertainment. The restaurant is located at 611 and 613 South Oxnard Boulevard.
