PLANNING AND ZONING PERMIT NO. 12-510-4 (Special Use Permit - Alcohol),** a request to upgrade the existing Type 20 (Off-Sale Beer & Wine) Alcoholic Beverage Control license to a Type 21 (Off-Sale General) license to authorize the sale of distilled spirits with the existing beer and wine for consumption off the premises. The existing hours of operation will remain unchanged, open 24 hours daily, with alcohol sales between the hours of 6:00 a.m. through 2:00 a.m. The project site is the Circle K store located at 2323 N. Thirty parking spaces are provided within the fenced property located at 271 Riverpark Boulevard. There are no significant changes to the exterior of the structure and landscaping is enhanced.
