PLANNING AND ZONING PERMIT NO. 14-630-01** (Specific Plan Amendment to the Rose-Santa Clara Corridor Specific Plan), a request for a text amendment to Section 4.2.2 of the Rose-Santa Clara Corridor Specific Plan to add Section 4.2.2, A. 7.0, "Public Transit Administration and Operations Facility". The Rose-Santa Clara Corridor Specific Plan comprises approximately 204 acres north of Highway 101 (Ventura Freeway) between the Rose and Rice Avenue freeway exits. There is no substantial evidence that the proposed project may have a significant effect on the environment, and a mitigated negative declaration (MND # 2014-01) will be adopted.
