F. PRESENTATION TO THE COMMISSION

1. SUBJECT: Presentation by DMV Ombudsman on services provided to Oxnard senior residents. Teresa Thompson gave a presentation on the services provided by DMV Ombudsman as well as changes within DMV due to COVID, allowing older adults to take tests at home.

2. SUBJECT: Presentation by Alzheimer's Association on services provided to Oxnard senior residents. Kathryn Cherkas provided information about the services the Alzheimer's Association provides in Oxnard and beyond.

1. SUBJECT: Senior Services Programs and Events. Jorge Cruz shared the Senior Nutrition Program meal count for April: 2,239 congregate meals and 1,740 home delivered meals, an increase in congregate meals as seniors seem to feel more comfortable about coming out. Staff held an Easter egg hunt in the Rose Garden,

which incorporated lots of walking. There was a combined Cinco de Mayo and Mother's Day celebration at each center. JP Morgan Chase Bank will do a series of presentations on financial scams and fraud.

Marisue Eastlake reported she is planning a TCMBB volunteer appreciation and is holding trainings for both Bone Builders and TCMBB instructors. World Tai Chi Day was a success, and she shared an article from the Tri-County Sentry.
