1. **Project Name: Garden City Acres Time Extension** - Planning and Zoning Permit Nos. 23-550-02 (Major Modification Permit to PZ# 17-200-04): A request for a time extension to extend the prior approved Garden City Acres Project (PZ# 17-200-04) in order to finish pursuing the submitted building permits for this project under the current planning entitlement (Development Design Review 17-200-04). This approved Development Design Review allows for the demolition of five of eight Garden City farmworker labor camp structures known as "Garden Acres" and proposes 29 studio and one-bedroom restricted
